This website www.justcasino.com ("Casino", "Website", "Company", "We", "Us", "Our") is owned and operated by Dama N.V. that is incorporated under the laws of Curacao with company registration number 152125 and having its registered address at Scharlooweg 39, Willemstad, Curação. Dama N.V. is operating under E-gaming license No. 8048/JAZ2020-13 issued by Antillephone N.V. authorized by the government of Curacão. Strukin Ltd. is a company incorporated under the laws of Cyprus with company registration number HE 407624 and having its registered address at Pavlou Nirvana & Aipeias 4, Alpha Tower, floor 1, flat/office 11, 3021, Limassol, Cyprus. Strukin Ltd. is a facilitating company within DAMA group. DAMA group is operating under E-gaming licenses of Curacão (8048/JAZ2020-13), Estonia (HKL000255).

The maximum deposit amount depends on the payment method you decide to use.

The Company does not accept third-party payments. You must only make deposits from a bank account, bank cards, e-wallets, or other payment methods registered in your name. Suppose we determine during the security

checks that you have violated this condition. In that case, your winnings will be confiscated, and the original deposit will be returned to the owner of the payment account. The Company is not responsible for the lost funds deposited from third-party accounts.

Withdrawal policy

The minimal amount for withdrawal is 20 EUR/USD, 30 CAD/AUD/NZD, 200 NOK, 1700 RUB, 335 ZAR, 0.0006 BTC, 20 USDT, 20 CHF. The maximum amount for withdrawal depends on the payment method you use. If the requested amount exceeds the limit of a particular payment system, the amount will be withdrawn in instalments.

The Casino reserves the right to check your identity prior to processing payouts and to hold any refund or withdrawals for the time needed to check your identity. In case you provide false Personal Data, the withdrawal can be refused and the Player Account terminated, of which you will be informed by email.

In order to verify a player's account, casino management requires documents (ID, payment systems, utility bills, etc) in Latin or Cyrillic alphabet. Dormant accounts

An inactive (dormant) account is a Player Account that a player has not logged into or logged out of for twelve (12) consecutive months. Suppose your Player Account is deemed to be inactive. In that case, the Casino reserves the

right to charge a monthly administrative fee of €10 or the equivalent in another currency (or the current balance of your account, if less) as long as the balance of your account remains positive.
